Senior Millage: We are in the 3rd quarter of the County fiscal year 2023-2024. We are projected to distribute over \$8.9 million to our Genesee County seniors through 37 contracts. 16 senior center contracts and 21 service provider contracts. Approximately 21,700 seniors were served with senior millage funding in FY 2022-2023. Annual reports are available and have been distributed. The current millage expires on 12/25/2025. It is up for renewal on the August 6th, 2024, ballot.
